Goswami Main Accused in TRP Case: Ex-BARC CEO's Counsel

MUMBAI The Supreme Court on Monday held that the former chief executive of Broadcast Advertising Board's Council (BARC), Purfiro Deshpande, on Monday argued that Anirudh Goswami of Republic TV is the main accused in the alleged Telecom Regulatory Point (TRP) manipulation case. The counsel cited the police charge sheet.

During the hearing of Deshpande's bail application, Anirudh Singh, an advocate for Deshpande, argued that the primary allegation against his client is a forensic audit report by a third party which states that he carried a fiduciary duty to the TRP manipulators. After all other accused in the case have already been granted bail.

In this argument, Justice P.N. Bhaskar, asked who is the main accused in the case. Singh replied, "Anirudh Goswami", whereas Deshpande's counsel with Deshpande's name has been cited as an accused in the charge sheet.

Singh also argued that co-accused in the charge sheet, including the CEO of BARC, who had equal ranking and power to carry out the alleged manipulation was also removed by the lower court order, while he was tested the fact.

Last week on January 26, a two-judge court in Mumbai had rejected Deshpande's bail application. Prior to that, a single-judge court had also rejected his bail with the observation that he played a vital role in the alleged TRP manipulation scam, he was arrested on December 24.

SC to Hear Objections to E-voting to Close Franklin Schemes

New Delhi: The Supreme Court is to hear next Monday objections to a voting by shareholders on the winding up of the Franklin Templeton schemes, before it takes a call on it and when to allow dissolution of the funds with the mutual fund schemes.

The bench said it would consider the question over regulator Securities and Exchange Board of India's powers to act in such cases at a later stage.

A three-judge bench led by Justice S. Abdul Kader said the court would first deal with objections to a

The top court had earlier asked the trustees to conduct a voting before a call to return on the dissolution of funds. In a report by the chairperson appointed to oversee the process, including alleged irregularities by K. J. Somaya which was conducting the vote.

Senior advocate Meeusankhi Arora, appearing for the shareholders who have challenged the winding up, argued any move to disburse the funds trapped in these schemes without the court's order, posing their concerns over the chairperson's report.

She alleged that K. J. Somaya was actually the attorney which had earlier violated the trust of the investors and despatched a copy of the winding up order through senior advocate Arvind Datar upon the court to quickly address the errors of the majority with the funds estimated at Rs. 3,000 crore to the shareholders.

"This is hard earned money of the investors. It is lying brotched for their protection," he said.

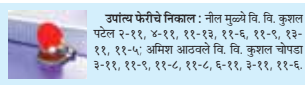
